- Summary Judgment in a federal employment case alleging violations of the California Family Rights Act and disability discrimination in violation of the Fair Employment and Housing Act (FEHA)
- Dismissal (not resulting from a settlement) after filing a motion for summary judgment in a federal civil rights case alleging claims of excessive force and various common law and statutory tort claims
- Dismissal (not resulting from a settlement) of a federal civil rights lawsuit for violations of constitutional rights and state law claims arising out of an alleged sexual assault
- Dismissal (not resulting from a settlement) after filing a motion for summary judgment in a state civil rights case where ten plaintiffs alleged claims for violations of the Fourth Amendment, conspiracy, assault/battery, negligent/intentional infliction of emotional distress, negligent supervision, violation of the Unruh/Bane Act, elder abuse, and child abuse
- Dismissal for waiver of costs in a federal civil rights case involving nine plaintiffs alleging conspiracy and violations of the Fourth Amendment for unlawful search and seizure
- Summary judgment in a state class action civil rights lawsuit
- Dismissal of an asbestos toxic tort action through informal negotiations
- Demurrer of survival claims in a benzene toxic tort action sustained without leave to amend(affirmed on appeal)
